General Terms & Conditions

Flokk

1. SCOPE

These general terms and conditions (the "Terms") apply to all orders and deliveries of products and services that Flokk, Inc. (the "Supplier") provides to its dealers ("Dealers").

These Terms form an integral part of all orders submitted by a Dealer ("Orders") and any deviation from these Terms must be made in writing duly signed by the Supplier in order to be effective.

2. ORDER CONFIRMATION

The Supplier's obligation to deliver a product or service pursuant to an Order is binding only when the Supplier has issued a written order confirmation to the Dealer (to the email address(es) stated by the Dealer on the Order).

The order confirmation shall include information regarding what product is being ordered, the price of the product and the estimated shipping date from the Supplier's facility.

The Dealer agrees to carefully verify that the content of the order confirmation is consistent with the Order and to provide the Supplier with prompt written notification of any discrepancies. If the Supplier has not received such written notice from the Dealer within 24 hours from the time the order confirmation was sent to the Dealer, the Order shall be deemed amended and the Dealer will be bound by the content of the order confirmation.

3. QUALITY AND MARKETING

The Dealer undertakes to comply with the Supplier's corporate identity rules and the Supplier's guidelines for brand management, as in effect from time to time, as well as such instructions, product presentations and profile material that the Supplier from time to time reasonably requests that the Dealer complies with. The Dealer acknowledges and agrees that a breach of any provision in such rules, guidelines or instructions shall be considered as a material breach of these Terms by the Dealer.

4. INTERNET SALES

The Supplier reserves the sole and exclusive right to use the internet to market, sell and deliver its products to the consumer/privacy market (B2C). The Dealer may only use the internet to market, sell and deliver to the professional market (B2B).

The Dealer undertakes to comply with the Supplier's corporate identity rules and guidelines, as in effect from time to time, and all other instructions for internet sales that the Supplier may reasonably request that the Dealer comply with. The Dealer acknowledges and agrees that a breach of any provision in such rules, guidelines or instructions shall be considered a material breach of these Terms by the Dealer.

5. QUALITY FOLLOW-UP

The Supplier reserves the right to monitor and enforce compliance with sections 3 and 4 by the Dealer.

6. TERMS OF PAYMENT

Unless otherwise agreed in writing, payment is due 30 days after the invoice date. If any payment is overdue, the Supplier is entitled to default interest on the outstanding amount at the rate of 10% per annum until full payment is made, in addition to all other remedies available under these Terms or at law.

7. PRICE ADJUSTMENTS

The Supplier has a right to continuously and at any time adjust its prices due to exchange rate fluctuations, changes in commodity prices, material changes in any of the Supplier's products, and upon other changes in the Supplier's cost basis that the Supplier could not reasonably have foreseen when confirming the Order with the Dealer.

8. WARRANTY

The only warranties given by the Supplier for any products and services provided to the Dealer are the warranties set forth in the Supplier's Price List.

THE SUPPLIER HEREBY WAIVES AND DISCLAIMS ALL OTHER WARRANTIES, INCLUDING ANY AND ALL IMPLIED WARRANTIES SUCH AS WARRANTY OF MERCHANTABILITY AND WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.

9. INTELLECTUAL PROPERTY

All intellectual property rights, such as patents, trademarks, design rights, copyrights and know-how, used in or relating to products offered by the Supplier, are the property of the Supplier and nothing in the Order or these Terms shall be interpreted or understood as a transfer of ownership of any such right.

The above notwithstanding, the Dealer has the right to, subject to the restrictions that the Supplier from time to time communicates to the Dealer, use the Supplier's trademarks free of charge for the sole purpose of marketing the Supplier's products, provided that such use complies with sections 3 and 4 of these Terms.

The Dealer shall promptly notify the Supplier if the Dealer becomes aware, or has reason to suspect, that a third party is infringing the Supplier's intellectual property rights.

10. TERMS OF DELIVERY

Unless otherwise agreed in writing, products are delivered DAP – Delivered At Place (Incoterms 2010). For orders with a total value of USD 800 or more (list price), the shipping cost is included in the price. A shipping fee of USD 40 will apply to orders with a total value of less than USD 800 (list price).

If the Dealer suspects that products have been damaged or stolen during transit, the Dealer must inform the Supplier within 48 hours of receipt, via e-mail at: info-us@flokk.com.

11. RETAINED OWNERSHIP

The Dealer acknowledges and agrees that Supplier shall retain title and ownership of any and all product shipped to the Dealer until the Dealer has fulfilled its obligations under the Order and these Terms, or if the Supplier terminates the Order before the Dealer has fulfilled its obligations under the Order and these Terms. The Dealer does not have the right, and agrees not to, without the Supplier's prior written consent, dispose of any products before they have been fully paid for.

12. ANTICIPATED BREACH

If the Supplier reasonably believes that the Dealer will not perform a material obligation under the Order or these Terms, the Supplier may suspend delivery of products and demand that acceptable security is provided for the Dealer's due fulfilment of its obligations.

13. THE SUPPLIER'S LIABILITY

The Supplier shall compensate the Dealer for defects in delivered products, provided that the defect existed at the time of delivery and provided that the defect was not caused or aggravated by abnormal or careless use of the product. The Supplier's liability is strictly limited to the supply of spare parts, redelivery of the product, or to provide a, in relation to the defect, reasonable reduction in the purchase price. The Dealer is not entitled to any other remedies.

THE SUPPLIER SHALL UNDER NO CIRCUMSTANCES BE LIABLE FOR INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND.

THE DEALER ACKNOWLEDGES AND AGREES THAT THE SUPPLIER'S TOTAL LIABILITY UNDER ANY CIRCUMSTANCES IS LIMITED TO THE PURCHASE PRICE THAT THE DEALER HAS PAID TO THE SUPPLIER FOR THE RELEVANT DELIVERY WHICH THE DEFECT OR THE CLAIM RELATES TO.

14. PRODUCT LIABILITY

If the Dealer receives a claim from a third party in any way relating to the Supplier's products, the Dealer shall forward a copy of the claim to the Supplier without delay, and the Supplier has the right to inspect all documents that have been and will be exchanged with the third party and shall be given an opportunity (but not an obligation) to, at its own cost and expense, assist in defending the Dealer.

15. EXCUSED PERFORMANCE

If the completion of an Order is obstructed or made unreasonably onerous due to circumstances beyond the Supplier's control, such as fire, war, requisition, confiscation, trade and currency restrictions, labor disputes, riot and civil commotion, shortage of transportation, general shortage of goods, restrictions in the supply of power and defects or delays in deliveries from suppliers caused by the above, the Supplier's performance under any Order and these Terms shall be excused.

Notwithstanding the foregoing, each party may terminate the Order by giving written notice to the other party if the Supplier's performance is delayed more than six (6) months as a result of any of the circumstances set forth in this section 15.

16. NOTICE OF CLAIM

Any claim by the Dealer against the Supplier must, in order to be valid and enforceable against the Supplier, be made in writing by the Dealer to the Supplier within one (1) year after the Supplier has delivered the product or performed the services that the claim relates to, except with respect to claims regarding breach of Supplier's product warranty which may be made in writing within [three (3)] months from the time the Dealer discovered, or reasonably should have discovered, the defect that allegedly constitutes a breach of warranty.

17. ENTIRE AGREEMENT

These Terms, together with any terms set forth in an Order or the applicable Price List, constitute the entire agreement between the Supplier and the Dealer with respect to Orders placed by the Dealer and products sold by the Supplier. If for any reason any part or section of an Order, the applicable Price List or these Terms is declared invalid or unenforceable, the remaining terms shall still be applicable and enforceable between the parties, subject only to such adjustments that may be necessary as a result of the invalid or unenforceable terms.

18. AMENDMENTS

The Supplier has a unilateral right to amend these Terms at any time without notice to the Dealer. To each Order submitted by the Dealer the latest version of these Terms will apply, and it is the Dealer's own responsibility to identify and familiarize itself with the latest version of these Terms when submitting an Order. The latest version is always available on the Supplier's website.

19. APPLICABLE LAW AND DISPUTE RESOLUTION

These Terms, and all Orders to which these Terms apply, shall be governed by the substantive laws of the State of New York, without regard to its conflict of law provisions.

Any dispute, controversy or claim arising out of or in connection with an Order or these Terms shall be finally settled by arbitration in accordance with the American Arbitration Association's Commercial Arbitration Rules. Regardless of the amount in dispute, the Expedited Procedures shall apply.

The seat of arbitration shall be New York City, and the language to be used in the arbitral proceedings shall be English.

20. ACCORDANCE WITH SANCTIONS LISTS

The Dealer acknowledges and agrees that under no circumstances is it acceptable to the supplier that Flokk products are distributed to persons, groups or entities on the UN consolidated sanctions list, the EU Financial Sanctions List or the Dutch Sanctions List. The supplier retains the right to suspend business with the dealer indefinitely, should it be proven that products have been distributed to persons, groups or entities on the aforementioned lists.

Payment Terms

Net 30 days. Interest charged for non-payment according to current terms. All goods remain the property of Flokk AS until payment is made in full.

Delivery Terms

For orders above list price USD 800, the transport cost is included. A surcharge of USD 40 will apply for orders below USD 800 (list price). In the case that goods have been damaged in transit, the recipient/customer must inform the supplier within 48 hours of receipt. **Email: info-us@flokk.com**

Change/Cancellation of orders

Change/cancellation of orders of chairs through the Quick Ship program is not possible. For orders outside the Quick Ship program, the order can not be amended or changed 24 hours after order confirmation has been sent. Each amended or cancelled order will incur a charge of USD 50 per order. Once production has started, orders cannot be changed. HÅG Warranty

General warranty terms and conditions

Flokk's warranty covers all HÅG chairs against material and manufacturing faults and defects from the chair's production date. The warranty covers any necessary spare parts. Labor and transport costs are not covered.

Wear and tear must be expected from normal use and are not covered by the warranty. Unless otherwise specified, the maximum weight for users is 250 lb.

The warranty is offered on the condition that the chair is used in normal conditions and for the purpose intended, and fabrics/leather undergoing normal cleaning and according to the specification of the fabric supplier. The guarantee does not cover the consequence of wear and stains when choosing a light (white) color for plastic or metal components.

Flokk reserves the right to make small construction alterations without notice.

10 year warranty for HÅG products and accessories

Flokk provides a 10 year warranty for all HÅG chairs and accessories that are in normal use for up to 9 hours per day. Please also see the general warranty terms and conditions above.

>9 hours/day – 5 year warranty.

Flokk provides a 5 year warranty for all HÅG chairs that are in normal use for more than 9 hours per day. Please also see the general warranty terms and conditions.

Spare parts guarantee

Flokk guarantees the delivery of spare parts for a minimum of 10 years after the chair's production date. The guarantee covers the parts necessary to maintain the chair's original functionality.

HÅG Fabrics and Colors

HÅG Standard collection

Flokk provides a 10 year warranty for fabrics/leather from the HÅG standard collection on fabric faults when the chair is in normal use for up to 9 hours per day and when used under normal conditions and for the purpose intended.

Flokk provides a 5 year warranty for fabrics/leather on fabric faults when the chair is in normal use for more than 9 hours per day.

For fabrics outside the HÅG standard collection, a 3 year warranty applies if not otherwise specified. Flokk provides a 3 year warranty on polyurethane and vinyl upholsteries. For quick ship fabrics Chicago, Sprint and Wollsdorf leather, the 10 year warranty applies.

Special or Customer specified fabrics/leather COM/COL.

The general warranty terms and conditions cover the chair against material and manufacturing faults, but not the upholstery. This does not affect your rights and obligations under local law. Customer specified fabrics/leather can only be used following approval by Flokk.

Approvals and Certifications

Flokk is ISO 9001 accredited.

The German test institutes, LGA and Intertek, have approved and issued the GS certificate (Geprüfte Sicherheit) for a number of HÅG products. HÅG task chairs are tested in accordance with both EN 1335 Type A (European office chair standard) and ANSI Bifma (American standard).

HÅG conference and visitor chairs are tested in accordance with EN 13761, EN 16139 and the ANSI Bifma standard.

HÅG SoFi, HÅG Inspiration and HÅG Excellence are tested according to British Standard BS 5459-2, a commonly used standard for intensive use (24 hours). The British Standard (BS 5459-2) tests that the chair will be suitable for more than 8 hours daily use and for persons weighing up to 330 lb.

ESD (Electro Static Discharge)

We can supply HÅG Capisco Puls 8010 and HÅG Capisco 8106 as ESD chairs upholstered in Global ESD (Bogesunds) in price group 6 +10%. Flokk provides a 5 year warranty on ESD chairs, conditional on castors and upholstery being cleaned regularly with a suitable cleaning agent. ESD is not available through the Quick Ship program and has a longer lead time. Please contact customer service for more information.

Cleanroom

We can supply HÅG Capisco Puls 8010 for Cleanroom, upholstered in Antistatic synthetic leather. Flokk provides a 5 year warranty on cleanroom finished chairs, conditional on casters and upholstery being cleaned regularly with a suitable cleaning agent. Cleanroom is not available through the Quick Ship program and has a longer lead time. Please contact customer service for more information.

Maintenance guide

Care of fabric upholstery:


Regular vacuum cleaning is recommended. Vacuum clean the chair with a furniture brush or wipe it with a clean white cloth or sponge slightly dampened with lukewarm, clean water. Marks and stains should be removed with a proprietary cleaner.

Care of leather upholstery:

Wipe with a slightly damp cloth and gently rub dry. A good proprietary hide food should be applied at least once year and more often if the leather is in a dry atmosphere or close to a heat-source. Do not remove any plastic parts or attempt to open the seating mechanism. Contact your Flokk dealer if the chair requires servicing or other maintenance. For additional maintenance advice, please contact customer service.
